The fees as approved include tuition fee, library fee, gymkhana fee, examination fee, development fee or amount payable for any curricular or co-curricular activities, laboratory fee, information brochure fee, and any other amount collected from the students, by whatsoever name called, and accepted in whichever manner, that is made payable to a Private Professional Educational Institution, for whatever purpose, by any candidate admitted to a professional course in any such Institution, but excludes any charges payable towards the use of any optional hostel accommodation, mess charges, and students Insurance fees.
- 2. Any amount accepted, recovered or charged by Unaided Institutions in cash or kind, directly or indirectly in excess or over and above the fees approved by the Fees Regulating Authority amounts to an Act of 'Profiteering' as defined u/s. 2(s) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 and the Management running such Institutions and be liable for penalty as provided u/s. 20 (1) of the said Act of 2015. The amount copenalty to be payable may extend to twice the amount taken in excess of the fees as determined by the Fees Regulating Authority.
