The meeting of the Internal Complaints Committee (ICC) was held on 06-01-2025 at 03:00PM in Conference room, PLITMS Yelgaon.

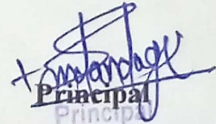
Mr. Sachin M. Dandage, Chairman, presided over the meeting.
